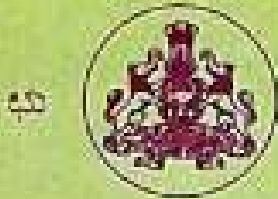

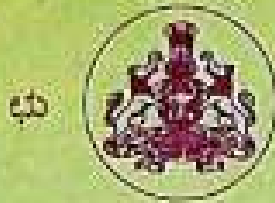

2. OBJECTS OF THE TRUST

i) To establish, support and promote the advancement of all Educational Institutions, including Kinder-Garden, Primary, Middle and High schools, Residential schools, and Colleges leading up to, and teaching, Degree, Post-Graduate and Doctorate courses in Arts, Science, Commerce, Engineering, Medicine, Law, Pharmacy, Central Nursing, Management, Ayurvedic Medicines, Technical and Technological, Music and Fine Arts, Architecture, Dumb and Deaf School, Laboratory X-Ray Training Center, Sports Training Center, Yoga Center, Management and other Professional, Commercial, Spiritual, and all kinds of education in Arts, and Crafts and Institutions of Researches in all Branches of Knowledge, and such other subjects as the trustees may deem fit for the benefit of the students of all castes, and communities and creeds.

ii) To train students to be human of character and efficiency.

iii) To formulate and implement schemes for spreading of education.

iv) To establish and administer, and to assist in establishing libraries, reading rooms museums, research institutions and hostels etc.,

v) To establish destitute Homes for providing food shelter and clothing to orphan children, the aged, and disabled persons free of cost.

vi) To establish Homes for the mentally retarded children, and help them through education, treatment and rehabilitation facilities.

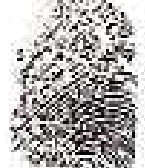
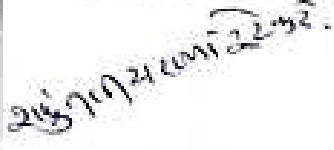

vii) To start orphanage shelters for children who have become orphans due to the negligence or death of their parents, and to provide them education and rehabilitation.

viii) To start Yoga centers, and to promote yoga practice scientifically, and to study its effects systematically

ix) To start Environmental Awareness centre, and Pollution Awareness Centre, and to educate, and encourage people to avoid pollution of the surroundings by plantation of trees etc.,

x) To support, and render financial assistance of charitable, educational causes institutions, and organizations, trusts, Societies in the form of donations, loans or otherwise on such terms as the trustees may deem fit or which, in the opinion of the trustees will help the realization of all or any of the objects of the trust.

xi) To give Scholarships fellowships, lectureships, professorships, awards, stipends, honorarium and to promote and encourage scholarships and research amongst all students and scholars irrespective of their caste community or religion.

xii) To set up charitable hospitals or other medical institutions and run them or grant subscriptions and donations to Hospitals, Charitable Dispensaries, convalescent Homes, asylums, Orphanages and other public institutions for Administering medical relief to the needy on philanthropic basis.

3. OTHER OBJECTS OF GENERAL PUBLIC UTILITY

i) To aid and assist by way of donations for the renovations repairs of temples, mosques, and churches, Gurudwaras, or other places as notified by the central Government in the Official Gazette for the purpose of section 80 G of the Income-Tax Act to be historic, archeological or artistic importance or to be places of public worship of re known throughout any State or states of India.

ii) To promote such other objects not inconsistent with the spirit of the trust inferred from the above and the trustees may add to the above mentioned objects having regard to the particular needs of the time, provided that, the application of the Trust's funds shall be done without distinctions of nationality religion, caste, class or sex, provided, this clause does not envisage expansion of the objects of the Trust or inclusion of any other object or objects which are inconsistent with or repugnant to the provisions of section 2(15), 11, 12, 13 and 80 G of the Income-Tax Act, 1961, or any other relevant provisions of the Income-Tax Act.

iii) To contribute funds to institutions having similar objects and which are recognized for the purpose of 80 G income Tax Act.

- (b) Any properties, moveable or immovable that may be acquired by the trust by purchase or otherwise.
- (c) All additions and accretions to the trust fund.
- (d) All voluntary donations both towards corpus or otherwise, gifts, legacies or grants in case or in kind accepted by the trustees.

ii. The fund and the income of the Trust shall be solely utilized for the achievement of the aforesaid objects, and no portion of it shall be utilized for payment to the trustees/Members by way of profit, interest or dividends etc.

iii. The trust property shall vest in the trustees who shall hold, manage and administer the trust in accordance with the terms and provisions of this deed of trust.

5. INVESTMENT OF TRUST FUNDS:-

The funds of the trust shall be invested in the modes specified under the provisions of section 13(1)(d) read with section 11(5) of the income tax Act, 1961 and other relevant provisions as amended from time to time.

6. APPLICATION OF INCOME AND TRUST FUND:-

The Trustees, shall, after providing for the above mentioned payment and disbursements, apply and utilize the net income of the corpus of the trust fund for the benefit of all mankind, without any discrimination on the ground of religion, section, caste or creed or community after complying with the provisions of the income tax Act 1961, or accumulate the whole or portion thereof for the benefit of all in a manner above referred to for the fulfillment of all or any of the above mentioned objects by such ways and means as the Trustees or their successors-in-office may, from time to time, in their absolute and unfettered discretion determine.

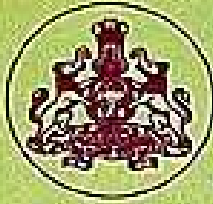

Nothing contained in the clauses hereinabove shall apply to any remuneration allowances, perquisites etc., paid or payable to any Trustee for the services rendered in any capacity other than as a Trustee such as the Principal, Professor, the Lecturer, the advisor, Doctor, Advocate etc., in any college or institutions run by the Trust and the Trustees may reimburse themselves from out of the trust fund all expenses which may be incurred by them in or about the execution of the objects of the trust and their powers under this deed of trust.

9 INDEMNITY :-

The trustees shall be kept fully indemnified and harmless by the trust against any loss or liability arising against them for anything done by them in good faith pursuant to the powers and authority conferred on them under this deed of trust.

The trustees shall be responsible for their own individual acts and defaults only and not for the acts or defaults of another of them nor for the acts or defaults of any banker, broker, auctioneer or other persons into whose

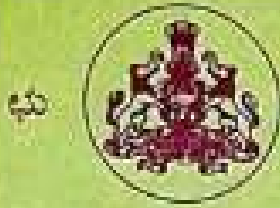

11. CONSTITUTION AND MANAGEMENT :-

Adherence to Regulations: All borrowing activities will be conducted in accordance with the legal regulations and guidelines governing such transactions between a trust and its Trustees.

18(b). Loan Application from External Sources:

This sub-clause authorizes the Trust to apply for loans from external financial institutions, banks, or non-banking financial companies (NBFCs).

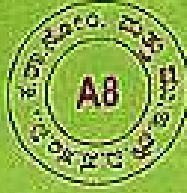

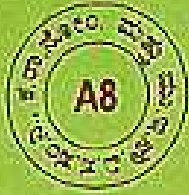
